## Dear fundholders and community partners,

Last fiscal year, GiveWell Community Foundation saw record high numbers in grantmaking and new funds. We also collaborated with the United Way of Central Florida to provide COVID-19 relief for nonprofits throughout Hardee, Highlands, and Polk counties through the United Community Relief Fund.

This fiscal year, we continued that trend, once again seeing record-high totals in giving and in growth, while collaborating with United Way of Central Florida again on an exciting new project. Both organizations have invested significant time and resources developing a comprehensive needs assessment for our three shared counties. The needs assessment report will be finalized by the end of 2022. We are very excited to share those results with you as we continue addressing our community's most pressing needs.

We are also pleased to share this annual report with you. It covers some of our accomplishments throughout the 2021-2022 fiscal year. A few quick highlights include \$35 million in grants, 85% of which went to nonprofits within our community; the addition of 46 new charitable funds, which brings us to 383 total funds; and \$229 million in total gifts, bringing our total assets to \$419 million. These amazing accomplishments are made possible thanks to our generous fundholders and partners throughout our community.

On behalf of the GiveWell Community Foundation Board of Directors and staff, we are very honored to be your philanthropic stewards and partners in building a better community.







## **GRANT CYCLES AND PROGRAMS**

### **Empower Polk**

Empower Polk is an annual invitation-only, competitive grant program of the GiveWell Community Foundation with the goal of empowering nonprofit organizations to become more efficient and sustainable. In total, \$113,126.79 was awarded through the 2022 Empower Polk grant cycle. Thirty-eight nonprofit organizations received capacity-building grants ranging from \$1,000 - \$5,000.

"We would like to thank the generous fundholders and donors who financially support Empower Polk and make this meaningful grant cycle possible," said GWCF's President and Chief Executive Officer, John Attaway. "Empower Polk is also supported by the members of our grants committee who spend hours reviewing, evaluating, and meeting to discuss each application to make the most impact for our community. We are very thankful for their time and dedication."

Funding for the Empower Polk grant cycle comes from donations made by fundholders and the public to the GWCF's Unrestricted Grant Fund. One hundred percent of these donations go directly towards empowering local nonprofits. Donations can be made to Empower Polk at givecf.org/donate. ## Community Clinic Grant Program

The Community Clinic grant program helps provide medical care for Winter Haven residents without access to medical insurance. In 2021, two nonprofit clinics were awarded grants from the program. Angels Care Center of Eloise received \$10,000 to help cover costs of dental care, eye surgery, and orthopedic injuries for indigent, migrant, and homeless residents. The Haley Center received \$10,666.25 to purchase a colposcope for detecting women's health issues and a point-of-care analyzer for monitoring diabetic patients. GWCF is grateful for the opportunity to administer these grants and for the continued support provided annually by the Yardley, England, Trimmer, and Orlich Charities Fund at the Central Florida Foundation.



## College Access and Career Readiness

GWCF awarded Polk Vision a grant of \$40,123.60 to support their work of improving students' chances of finishing high school, getting into college, or finding immediate careers through job training and certifications. Funding for this grant came from a combination of donations raised by GWCF and a matching grant from the Florida Philanthropic Network (FPN)'s College Access Success & Initiative (CASI) 2.0. Through the CASI 2.0 program, FPN is engaging Florida community foundations in the work of local college access networks (LCANs). CASI 2.0 is sustained with funding from the Helios Education Foundation and Kresge Foundation.

## Impact Polk

Impact Polk is an annual competitive, donor-directed grant program of the GiveWell Community Foundation with the goal of addressing community needs throughout Polk County. Impact Polk grants often support a broad range of needs, such as animal welfare, arts and culture, education, and health and human services. GWCF awarded a total of \$835,509 to 83 nonprofit organizations through the Impact Polk 2022 grant cycle. Thank you to the George W. Jenkins Fund within the GiveWell Community Foundation which provides annual funding for the Impact Polk grant cycle. More information on this grant cycle can be found at **impactpolk.org**.

# United Community Needs Assessment

In early 2022, GiveWell Community Foundation and United Way of Central Florida (UWCF) announced the launch of the United Community Needs Assessment (UCNA) covering our shared services areas of Polk, Hardee, and Highlands counties. By partnering through the UCNA, we aim to identify critical community needs and implement initiatives to address those needs. Results of the needs assessment will also be shared with municipalities, businesses, service clubs, and the general public.

GWCF and UWCF hired Q-Q Research Consultants to accomplish this comprehensive assessment. From February to May 2022, insight and opinions from residents around the tri-county area was collected through an online survey and in-person focus groups. Feedback was collected on a variety of critical issues such as education, economy, employment opportunities, infrastructure, quality of life, and transportation.

The final report is currently being compiled by Q-Q Research Consultants, and we anticipate the full UCNA report will be completed and available to the community by the end of 2022.

## Nonprofit Workshop

On October 28, 2021, GiveWell Community Foundation hosted its fourth annual Nonprofit Workshop at Lone Palm Golf Club in Lakeland. This half-day fundraising seminar was available exclusively to local nonprofit organizations with GWCF agency funds. During this year's workshop, nonprofit board members and executive directors learned about topics ranging from board responsibilities to planned giving.

Carter representatives, Steve Higgins, CFRE, President/CEO, and Stacy Williams, CFRE, Managing Director, led an interactive session focused on energizing board members, maximizing their impact, and deciphering the roles of board and staff members.

Next, a presentation by Beverley McLain, MBA, CAP of McLain Consulting LLC, answered questions many nonprofits have about planned giving. Questions such as: why should we put resources toward planned giving when we need gifts now; who are these planned giving donors, and where would we find them; what if it's too complicated; and what do donor advised funds have to do with planned giving?









## Friends of the Foundation

The inaugural Friends of the Foundation event on May 5, 2022, was GWCF's first fundholder event since the COVID-19 pandemic started in 2020. Hosted at Bok Tower Gardens in Lake Wales, the event provided a wonderful opportunity for fundholders and community partners located in the eastern region of our service area to connect and to hear updates from the Foundation.








## **FUNDS OF THE FOUNDATION**

GiveWell Community Foundation is proud to manage 383 funds for individuals, families, businesses, and nonprofits, representing \$419 million in charitable assets.





#### TYPES OF FUNDS

**Donor Advised Funds** are established by donors who retain the right to recommend grants to nonprofits.

**Agency Funds** are created by nonprofits to protect and invest their assets for the future of their work and mission.

**Designated Funds** are established to benefit a particular organization or project.

**Legacy Funds** allow donors to leave a legacy of giving by incorporating charitable giving into their estate plans.

**Community Funds** allow municipalities, local service clubs, and community groups to improve the quality of life of our area.

**Memorial Funds** honor a loved one by supporting causes or nonprofits which would have pleased that person.

**Field of Interest Funds** create a resource to target an area of interest to the donor, such as education or arts and culture.

**Unrestricted Funds** enable GWCF to address current community needs and allows the public to participate by pooling donations.
